Bexar County Emergency Services District No. 5 conducted a meeting at 7120 East 6th Street, Somerset, Texas 78069 at 6:00 pm via Zoom Link as well as in person. Board members and the public were given a phone number, a URL, a meeting ID and password to join the meeting and to allow for public comments. Effective March 16, 2020, Governor Gregg Abbott authorized the temporary suspension of some of the statutory provisions of the Texas Open Meetings Law. This Meeting of the Bexar County Emergency Services District No. 5 Board of Commissioners is being held pursuant to this authorization and will limit face-to-face meetings to slow the spread of the Corona Virus (COVID19).

1) Call the Bexar County Emergency Services District No. 5 meeting to order and establish a quorum.

- 5) Reports, presentations, and funding requests with action taken as appropriate:
 - a) Bexar County ESD 5 Fire and Rescue

Chief Estep gave his monthly report on call volumes, training, and response to Covid 19. Chief Estep also reported Government Capital's change in financing terms for the Mini Pumper. They will no longer honor the quote of a 2 year deferred term but will offer an 18 month deferred. He said this still puts the first payment due into the 2022 budget. No action was taken. This was for information only.

 - a) Discussion and possible action regarding the Montgomery Road Station, including but not limited to approval of the architectural design

There was a brief discussion on one minor change on the architect's rendering of the building but Chief said it was close enough for a sign. The architect also suggested a flood study even though it was not in the 100 year flood plain. Legal Counsel will talk to the engineer about this. No action taken.

- b) Personnel issues: Including but not limited to hiring, terminations, discipline, suspensions, and compensation, and any other related matters, including possible adoption of a leave policy for the general manager
 - There was a brief discussion regarding admin working from home. Commissioner Flores suggested waiting to address this at the next meeting. He also wanted the other commissioners to review the leave policy to be addressed at the May meeting.
- c) Discussion and possible action regarding the litigation with the Somerset Volunteer Fire Department in reference to Cause No. 2019-CI-08846

Motion by Commissioner Schneider to authorize a settlement with Somerset VFD with a monetary amount per the contract requirements contingent on receiving their paperwork and returning their equipment to them. Seconded by Commissioner Flores. Motion carried.
