Director Dalros said the platting process is complete and just needs to be signed. He said Chief should be able to pull the county permits, but Chief said LK Travis is handling all that. Legal Counsel said the request for bids must be published in the paper.

b) Discussion and possible action in regards to bids received for the water well for the Montgomery Road area station and authorize execution of a contract with the most suitable contractor

Director Dalros said the bid packets have been sent out and he expects to receive the bids by June 1. No action taken.

- c) Discussion and action, if necessary, regarding a site for a future fire station (Dalros, Pierce)

 Director Pierce said he is trying to get on the Land Committee agenda for the meeting that should be around June 13. No action taken.
- d) Discussion with possible action regarding presentation by Rob Killen, Attorney with Killen, Griffin, & Farrimond at the 10/7/2021 Special Meeting on possible donated land *No discussion or action on this item.*
- e) Discussion and possible action regarding the purchase or repair of a generator for one or more stations
 - Chief reported that the parts are on order, and it remains in the shop.
- f) Discussion and possible action regarding the purchase of portable and mobile radios

 Chief reported that as of September 1, the current radios won't work with the new county
 dispatch system. The county may supply radios as they have in the past, but it does not seem
 likely. Director Flores pointed out that the radio purchase was part of the long-range plan.
 Chief presented a proposal for \$117,000. Director Postert directed Chief to proceed with
 proposals, payment schedule and, timeline of delivery and bring back to the board at the Special
 Meeting on May 26th.
