*Motion by Commissioner Schneider to propose a .10 tax rate for 2021. Seconded by Commissioner Dalros with Herschel Postert voting in favor; Howard Dalros voting in favor; Andrew Flores voting in favor; Becky Schneider voting in favor; and Robert Pierce voting in favor. Motion carried.*

- d) Set date for public hearing and meeting to adopt 2021 tax rate**
