b) Lytle Volunteer Fire Dept.

Chief Garcia reported on continuing training for his department. He reported his engine is out of service for a repair that may cost \$8000, however, his older engine is in service. Chief Garcia reported 45 calls in district with an average 9:01 response time and 8 calls out of district with a 9:00 average response time.

9) Action items:

- a) Discussion with action taken as appropriate regarding the future fire station on Montgomery Road, including any action as necessary for the bid process, status of platting, water drilling issues, and any other matters related thereto Commissioner Dalros said he met with the county last week and was told that any road longer than 150 feet must have an egress so the county will not budge on the road. He does want to see if the county will agree to build and maintain the road though since they already have all the equipment. He said the paperwork is in the permitting process at Public Works. Marcus Primm from the Commissioner's office said he will make sure the process is expedited. This item was also addressed in Executive Session.
- b) Discussion and possible action regarding the future fire station in the IH35 / Pearsall Rd area, including environmental surveys, ratification and approval of the contract with Galm Real Estate, LLC, and any other matters related thereto

Commissioner Postert said the property is currently being cleaned up and he would like a sign out there as soon as possible. Legal Counsel told the board they must ratify the contract with
