*Effective March 16, 2020, Governor Gregg Abbott authorized the temporary suspension of some of the statutory provisions of the Texas Open Meetings Law. This meeting of the Bexar County ESD 5 Fire and Rescue Board of Directors is being held pursuant to this authorization and will limit face-to-face meeting to slow the spread of the Corona Virus (COVID19).*
