SPECIAL MEETING AND BOARD WORKSHOP

In accordance with the Texas Open Meetings Act, Chapter 551, Texas Government Code, the Board of Commissioners of Bexar County Emergency Services District No. 5 had a SPECIAL MEETING and BOARD WORKSHOP at 7120 E. 6th Street, Somerset, TX 78069 on AUGUST 11, 2022 at 6:00 pm.

- 1) Call the Bexar County Emergency Services District 5 meeting to order and establish a quorum.**

Meeting was called to order at 6:03 pm and a quorum was established. Board members in attendance were Herschel Postert, Howard Dalros, Andrew Flores, and Robert Pierce. Becky Schneider was absent.

- 2) Invocation: Pledge of Allegiance to the American Flag.**

Pledge recited.

- 3) Discussion and action to propose a tax rate for FY2022-2023; set date for Public Hearing; set date to adopt the 2022 tax rate; and name the newspaper of record for required publication**

There was a discussion about the NNR, VAR, and DeMinimus rates as well as the budgetary needs of the District. And the fact the District has been at a 10 cent rate since 2011 according to Commissioner Postert.

Motion by Commissioner Dalros to propose a 10 cent tax rate, set a Public Hearing on 8/25/22 at 6:00 pm, and publish in the Express News as required at least 5 days before the Public Hearing. Seconded by Commissioner Pierce. Vote; Postert – aye, Dalros – aye, Flores – aye, and Pierce – aye. B. Schneider was absent.

- 4) Discussion with action taken as appropriate regarding the future fire station in the Montgomery Road area, including but not limited to bid process, financing, conveyance of the real property to Bexar County, including resolutions, if any, and any other matter related thereto.**

*Commissioner Dalros spoke of the warranty deed and the language saying that if the property is no longer being used as a fire station, it will revert back to the County. Commissioner Dalros expressed a concern about securing financing with the language included. Commissioner Dalros also suggested waiting on the well until the name change is made.
